



ENVIRONMENTAL POLICY

A. Benevenuta & C. Spa is aware of the impact its business can have on the environment and considers respect for the environment to be an integral part of its business. For this reason, A. Benevenuta & C. Spa has decided to implement an Environmental Management System that complies with the UNI EN ISO 14001:2015 standard.

To this end, it is committed to:

- operate in the context of reference for the identification and mitigation of risks related to the activity, applying the logic of risk-based thinking in the management of processes;
- operating in compliance with applicable environmental laws and regulations and any other environmental requirements that the organization may have subscribed to, such as Customer Specific Requirements (CSRs), ensuring stakeholder satisfaction;
- performing its activities in order to protect the environment, contributing to the prevention of pollution;
- periodically analyze the environmental aspects related to its activities, assessing their impacts taking into account the ecosystem context and requests from stakeholders.

The organization is committed to the analysis and minimization of the environmental impacts of the following aspects:

- *Use of energy resources*, with the aim of improving energy efficiency and implementing possible renewable energy sources;
- *Use of water resources*, with the aim of improving water quality and consumption & management;
- *Use of raw and auxiliary materials and Hazardous substances*, in order to have responsible chemical management and sustainable resource management;
- *Waste reduction*, with the aim of increasing, if possible, the percentage of waste going to recovery;
- *Atmospheric emissions*, with the aim of reducing, if possible, GHG emissions and increasing air quality;
- *Noise*, with the aim of minimizing noise emissions to possible sensitive receptors;
- set goals and targets for improvement and implement related programs, including through the empowerment and training of all personnel involved;
- ensure effective surveillance and monitoring of the activities performed;
- adopt all plant and management arrangements to prevent and respond to emergencies;
- involve all people working for or on behalf of the organization, spreading an ever-growing culture of respect for the environment;
- comply with explicit and implicit contractual commitments, taking care of communication and assistance towards the customer;
- apply a methodology of continuous improvement of its management system, increasing environmental performance.
